#### 1. Request:

The complainant requested the following information from Ministry of Justice on 16 June 2024:

- "1. The JCIO Its Numbers and Categorisation of Persons Employed at JCIO Please identify the number of persons employed in the provision of the JCIO Service in each of the following categories as near as available: -
- 1.1 Numbers & Categorisation of Non-Judicial Persons (persons who are not judges)
- 1.1(a) Direct employee of JCIO.
- 1.1(b) Not Direct Employee of JCIO but Direct Employee of MoJ.
- 1.1(c) Other persons: e.g. consultants, agency etc. please state description (Only approximate estimate of typical number required for this item 1.1(c))
- 1.2 Judicial Persons (persons who are judges) for each of above a) to c) categories.
- 1.2(a) Direct employee of JCIO.
- 1.2(b) Not Direct Employee of JCIO but Direct Employee of MoJ.
- 1.2(c) Other persons: e.g. consultants, agency etc. please state description (Only approximate estimate of typical number required for this item 1.2(c))

## 2. Commissioner's Decision:

Therefore the Commissioner finds a breach of section 10.

### 3. Steps:

The public authority must provide a substantive response to the request in accordance with its obligations under FOIA.

The public authority must take this step within 30 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.
