

## **Freedom of Information Act 2000 (Section 51)**

### **Information notice**

#### **Section 51**

---

Under section 51 of the Freedom of Information Act 2000 (FOIA), which is set out below, the Information Commissioner (the Commissioner) has the power to serve a notice on a public authority requiring it to furnish him with any information he requires to enforce the requirements of FOIA.

51. – (1) If the Commissioner –

(a) has received an application under section 50, ...

he may serve the authority with a notice (in FOIA referred to as “an information notice”) requiring it, within such time as is specified in the notice, to furnish the Commissioner, in such form as may be so specified, with such information relating to the application, to compliance with Part I or to conformity with the code of practice as is so specified.

#### **Application under section 50**

---

1. The Commissioner has received an application under section 50, reference IC-285152-F3S4, for a decision whether a request for information made by the complainant to The National Archives on 15 May 2023, has been dealt with in accordance with the requirements of Part I of FOIA.

## **Nature of complaint**

---

2. The Commissioner wrote to The National Archives on 16 April 2024, instructing it to provide its submissions a copy of the withheld information in respect of the complaint.
3. The National Archives contacted the Commissioner on 19 April 2024 to advise that it intended to disclose a redacted version of the requested information, but stated that this required consultation with the Crown Prosecution Service to gain approval. It advised that it would therefore not be able to meet the Commissioner's , but it did provide a copy of the withheld information.
4. As The National Archives will not be able to either provide the requested information to the complainant, or its submission to the Commissioner within the specified timescale, a formal legal deadline for it to provide its response has been imposed.

## **Information required**

---

5. In view of the matters described above the Commissioner hereby gives notice that in the exercise of his powers under section 51 of FOIA he requires that The National Archives shall, within 30 calendar days of the date of this notice, furnish the Commissioner with a copy of the following information:
  - Confirmation that a redacted copy of the requested information has been sent to the complainant, or
  - A substantive response to the questions posed in the Commissioner's letter dated 16 April 2024.

## **Failure to comply**

---

6. Failure to comply with the steps described above may result in the Commissioner making written certification of this fact to the High Court (or the Court of Session in Scotland) pursuant to section 54 of FOIA, and may be dealt with as a contempt of court.

## Right of appeal

---

7. There is a right of appeal against this information notice to the First-tier Tribunal (Information Rights). Information about the appeals process can be obtained from:
