While my focus is on Costco, Please do not limit the scope of the request to Costco. I wish to know all organisations that provide benefits to the ICO and Staff."

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We have interpreted your request as being for information about organisations external to the ICO that provide discounts or benefits to ICO staff members. We have separated our response into two parts below – first, our response specifically where your request relates to information about Costco, and then further as your request relates to information about other organisations.



I would like to discover if Costco provide discounts, free membership, or similar benefits to the ICO and/or ICO staff. Please provide detailed info regarding Costco.

Costco do not provide discounts or free membership to ICO staff. However, ICO staff do qualify for Individual Memberships at Costco. You can find more details about this membership at www.costco.co.uk/membership.

It is important to note that, while ICO staff are eligible for an Individual Membership with Costco, this is not a free membership. ICO staff who wish to obtain this membership must pay the membership fee themselves.

BHSF Network Benefits is an employee benefit scheme offers discounts to ICO staff from participating retailers. You can find more information about this on the BHSF website at www.bhsf.co.uk/online-discounts/. The ICO does not hold a list of participating retailers in our systems, as these organisations do not have direct agreements with the ICO.



The ICO have partnered with Cycle2Work to offer a Cycle to Work Scheme to ICO staff members. The scheme provides savings on bikes and cycling equipment through a salary sacrifice agreement. This applies to bike brands available on the UK market via Halfords, Tredz or Cycle2Work's network of independent bike shops.

The ICO's Colleague Assistance Programme / Employee Assistance Programme is a confidential service that provides a telephone counselling service, legal support service, financial support service and medical support service at no cost to ICO staff members.

The ICO's health cash plan provides cover for staff towards the costs of a range of everyday healthcare expense such as dental treatment, diagnostic consultations and eye care. The insurance policy is sold by BHSF Employee Benefits Limited and underwritten by BHSF Limited.

The ICO also offers staff free BUPA medical health checks once staff members have been with the ICO for two or more years.

The ICO also provides free eye tests for ICO staff at Clare & Illingworth on Water Lane in Wilmslow. Alternatively, staff can make an appointment with an optician of choice and can claim up to £35 back from the ICO. The ICO will also contribute up to £42 for recommended glasses for staff members.
