Request

You asked us:

"Specifically, I would like to request the following:

- The total number of data breach reports received by the ICO in the year 2022.
- A breakdown of these reports by industry sector (e.g., healthcare, finance, education).
- The number of investigations initiated by the ICO as a result of these reports.
- The average time taken to conclude these investigations.
- The number of penalties or fines issued as a result of these investigations and the total amount collected in fines for the year 2022."

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We do hold information in scope of this request. We publish certain information about data security breaches reported to us online.

Data security incident trends | ICO

We would signpost to our Data Security Incident Trends Dashboard for relevant information. There were 8,798 data breach reports received in 2022. This total can be found under the time series tab. On the same tab you can apply filters, which include a 'Sector' filter, to find our how many data breach reports were received from each business sector.

To find out the total number of investigations initiated in 2022, apply the 'Decision Taken' filter on the time series tab. There are 545 data breach report cases where the decision taken was 'investigation pursued'. The



cross-tabs may also be of interest for a breakdown of incident type, by decision taken.

Where the decision recorded on a data breach report case is investigation pursued. Then the incident is passed to our Investigations department because it is serious enough to be considered for full investigation and potential regulatory action. We routinely publish quarterly investigation data sets online.

The average time taken to conclude such investigations can be worked out using the published data sets. It may be helpful to refer to the start date and date closed columns in the data sets for this purpose.
