I am writing with regard to a complaint the Information Commissioner's Office (ICO) has received from [REDACTED] about an information request [REDACTED] submitted to the London Borough of Hackney (the Council).

This complaint has now been allocated to me for consideration and I will be your point of contact for any queries you may have about our handling of this case.

I have set out below my understanding of [REDACTED] request, the nature of [REDACTED] complaint to the ICO and the response I would like the Council to provide me with at this stage.

The request

I understand that [REDACTED] submitted the following request to the Council on 25 June 2021:

'Please provide a copy of any correspondence from or with Birmingham City Council since 2012 regarding housing residents from your borough within Birmingham. Please note, this request does not cover discussions about individuals but about the policy/principle/practice etc of finding homes in Birmingham (e.g any objections or encouragement from Birmingham or requests to them to identify a number of properties)'

The Council responded on 13 July 2021 as follows:

'We would like to inform you that we have searched our records and some of the information you requested is not held by Hackney Council. Unfortunately, as you may be aware, Hackney Council has experienced a

serious cyber-attack that has caused significant disruption to our delivery of day-to-day services. Consequently it is not possible for all housing records to be accessed at this time. Since the cyber-attack in October 2020 there is no record of correspondence between Hackney Council's Housing Supply team and Birmingham City Council, with this regard; however I regret that the service is unable to check records going back to 2012 at this time.'

██████████ contacted the Council on 13 July 2021 and queried whether the position was that the information was not held or that it could not be currently accessed.

The Council responded on 28 July 2021 and noted that its previous response explained why the requested information was not available.

Nature of complaint

██████████ has complained to the ICO about the Council's failure to provide ██████████ with the information ██████████ requested.

Response needed

Clarification of the Council's current position for information pre-dating October 2020

I appreciate that when the Council processed the request in July 2021 it was unable to check whether any relevant information was held which pre-dated the cyber attack.

Please confirm whether this remains the position with this request or whether the Council is now in a position to search for relevant information which pre-dates October 2020.

If the relevant records can still not be accessed

If the records pre-dating October 2020 can still not be accessed, then please outline the steps that the Council has taken to recover the housing records that would contain the requested information (assuming that such information would be held).

Does the Council envisage being in a position when such records will be sufficiently recovered that it would be able to search for any information pre-dating October 2020?

If the relevant records can now be accessed

Alternatively, if the Council is now in a position to search the relevant records to locate information pre-dating 2020, please do so at this stage.

If the Council locates any information falling within the scope of this request, please provide this to [REDACTED] (copying in the ICO).

If the Council considers any of this information to be exempt from disclosure, please provide the ICO with a copy of this information and explain which exemption(s) within FOIA it considers to apply to this information and why.

If the Council is now able to search the records pre-dating October 2020 but cannot locate any information falling within the scope of the request, please explain in detail the nature of the searches undertaken for such information.

Information post dating October 2020

I understand that the Council has searched, but has not located, any information which post dates the cyber attack.

Please explain the nature of the searches undertaken to locate such information and explain why such searches would have been likely to locate any information if it were held.

In doing so, please explain the search terms used and explain the nature of the records / storage systems that were searched.

Time for a response

I would appreciate a response to the above queries within 20 working days.

I understand that [REDACTED] submitted the following request to the Council on 25 June 2021:

'Please provide a copy of any correspondence from or with Birmingham City Council since 2012 regarding housing residents from your borough within Birmingham. Please note, this request does not cover discussions about individuals but about the policy/principle/practice etc of finding homes in Birmingham (e.g any objections or encouragement from Birmingham or requests to them to identify a number of properties)'

The Council responded on 13 July 2021 as follows:

'We would like to inform you that we have searched our records and some of the information you requested is not held by Hackney Council. Unfortunately, as you may be aware, Hackney Council has experienced a

serious cyber-attack that has caused significant disruption to our delivery of day-to-day services. Consequently it is not possible for all housing records to be accessed at this time. Since the cyber-attack in October 2020 there is no record of correspondence between Hackney Council's Housing Supply team and Birmingham City Council, with this regard; however I regret that the service is unable to check records going back to 2012 at this time.'

██████████ contacted the Council on 13 July 2021 and queried whether the position was that the information was not held or that it could not be currently accessed.

The Council responded on 28 July 2021 and noted that its previous response explained why the requested information was not available.

Nature of complaint

██████████ has complained to the ICO about the Council's failure to provide ██████████ with the information ██████████ requested.

Response needed

Clarification of the Council's current position for information pre-dating October 2020

I appreciate that when the Council processed the request in July 2021 it was unable to check whether any relevant information was held which pre-dated the cyber attack.

Please explain the nature of the searches undertaken to locate such information and explain why such searches would have been likely to locate any information if it were held.

In doing so, please explain the search terms used and explain the nature of the records / storage systems that were searched.
