### **Request for information**

"Does the Information Commissioners Office hold ISO 9001 or 27001 certification? If so please could this be attached by reply?

Does Information Commissioners Office have an Information Security or Privacy Policy available?"

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). This legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

# Our response

In reference to ISO certifications 9001 and 27001, we do not hold the certifications requested for the reasons given below.

The ICO is the UK's independent authority established to uphold information rights in the public interest; promoting openness by public bodies and data privacy for individuals. You can read more <u>about the ICO</u> on our website.

As an independent regulatory authority we do not provide a product or service in the sense of your request. It may be helpful to explain that we are sometimes contacted by organisations who think we are a supplier, and ask us for certifications as part of their contract management due diligence. This can happen because those organisations pay the <u>data protection fee</u> to the ICO, which results in us erroneously appearing on their supplier list.

Regarding the second part of this request, you can access both the <u>ICO Privacy</u> notice and other ICO Policies and procedures on our website.

As this information is already reasonably accessible to you, technically it is withheld under section 21 of the FOIA. Section 21 states that we don't need to provide you with a copy of information when you already have access to it.

This concludes our response to your request.
