# Request

We received your request on 26 July. You asked for the following information:

Please provide copies of communications sent or received by the ICO to/from NatWest, Coutts, Nigel Farage and the BBC concerning the breach of Nigel Farage's personal data admitted by both NatWest and the BBC this week.

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). As you are probably aware, this legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

#### Our response

## **Section 40 FOIA – Personal information**

Ordinarily, a public authority has a duty to confirm or deny whether it holds information and to provide that information to the applicant, unless an exemption applies.

Section 40(2) FOIA states:

"Any information to which a request for information relates is also exempt information if—

- (a) it constitutes personal data which does not fall within subsection (1), and
- (b) the first, second or third condition below is satisfied."

Section 40(3A), which sets out one of the three conditions, states:

"(3A) The first condition is that the disclosure of the information to a member of the public otherwise than under this Act—



- (a) would contravene any of the data protection principles, or
- (b) would do so if the exemptions in section 24(1) of the Data Protection Act 2018 (manual unstructured data held by public authorities) were disregarded."

Finally, section 40(5B)(a) states:

"The duty to confirm or deny does not arise in relation to other information if or to the extent that any of the following applies—

- (a) giving a member of the public the confirmation or denial that would have to be given to comply with section 1(1)(a)—
- (i) would (apart from this Act) contravene any of the data protection principles"

You have requested information held concerning a data protection complaint made by an individual. This information, if held, would constitute the personal data of those individuals as it relates to an identified natural person. Section 40(2) of FOIA exempts disclosure of the personal data of others, subject to conditions.

Section 40(3A)(a) details one of these conditions. In my view, this condition would be met in this case because disclosure of the information you have requested, if held at all, would break the first principle of data protection – that personal data is processed lawfully, fairly and in a transparent manner.

However, while I consider that information in scope of your request, if held at all, would be exempt information, I have considered whether our duty to confirm or deny even arises in the present case. I consider it does not because in my view, section 40(5B)(a)(i) is engaged in that confirmation or denial of whether we hold the information you have asked for would (1) constitute their personal data, because it would reveal whether or not they had contacted us to make a complaint about a specific issue concerning their own personal data, as well as further details about the status of the complaint, if there was ones, and the work we had done in relation to it, and (2) disclosure would break the first principle of data protection as detailed above.

We consider that Data Subjects who contact us to make a data protection complaint have a reasonable expectation that we would not disclose into the public domain, any information about their complaint from which they are identifiable, including information which would reveal whether or not they had made a complaint to us about a specific issue.



With the above in mind, our response to your request is that we can neither confirm nor deny that we hold the information that you have requested.

This should not be taken as any indication of whether we hold this information or not.

This concludes out response to your request.

## **FOI** review procedure

Your request for internal review should be submitted to us within 40 working days of receipt by you of this response. Any such request received after this time will only be considered at the discretion of the Commissioner.

If having exhausted the review process you are not content that your request or review has been dealt with correctly, you have a further right of appeal to this office in our capacity as the statutory complaint handler under the legislation.
