Just a quick message to say that I've now managed to speak to colleagues internally regarding the Facewatch case and things are progressing towards a conclusion via our internal sign off processes. As I understand it an outcome is imminent very shortly in the next week or two. We need to engage directly with the parties involved in the first instance so I can't give any more detail at this stage but I did want to let you know that things were moving in light of your email below. I appreciate that Ministerial letters may well be in train and may have to take their course but I did just want to update you as much as I could for now. I will try to keep you posted when I'm in a position to say more.
