## **Request for information**

Request received 16 August 2023:

"When did the ICO reduce the time limit for the submission of complaints to the ICO regarding a public authority's handling of information requests under the Freedom of Information Act or Environmental Information Regulations? Please be as specific as possible i.e. please supply the month and year.

*I note that the time limit for bringing complaints to the ICO is now six weeks. What was the time limit prior to the time limit of six weeks?"* 

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). As you are aware, this legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

### **Our response**

We do hold information in scope of your request.

The change referred to was made in April 2023, reducing the time limit to six weeks from the previous limit of three months.
