# **Request for information**

Request received 2 August 2023:

"What does the ICO know about Devon County council's backlog of subject access requests? What enforcement action is/has the ico taken against Devon County Council? If the ico knows about the backlog, when did it become aware? How long has it given Devon County Council to resolve the backlog, which is apprently going to take about 9 months?"

To the extent that your request is for recorded information we hold, it has been handled under the Freedom of Information Act 2000 (the FOIA). This legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

### Our response

We can confirm that our Public Advice and Data Protection Complaints Service (PADPCS) were made aware in March 2023 by Devon County Council (DCC) of their backlog of Subject Access Requests. PADPCS were further advised in April 2023 of DCC's plans to clear the backlog.

No enforcement action has currently taken place or been planned. The ICO publishes <u>Enforcement action</u> we have taken on our website. To date, the ICO have not imposed a deadline for Devon County Council to resolve the backlog.

For information, we also publish <u>Complaints and concerns data sets</u> of our casework, in line with our <u>Communicating our Regulatory and Enforcement Activity Policy</u>. These include casework relating to data protection complaints.

This concludes our response to your request.



## **FOI** review procedure
