Your request

You asked us for the following:

- "A copy of the ICO's strategic plan for tackling online tracking that erodes privacy through the use of ad-tech
- How many enforcement actions have been taken since 2021 and the ICO reopening of its adtech investigation https://ico.org.uk/about-the-ico/media-centre/news-and-blogs/2021/01/adtech-investigation-resumes/ (Please note, I am not interested in action taken over unsolicited calls and texts.)"

We received your request on 8 June.

Where your questions satisfy the criteria of a valid information request, we have considered your request under the Freedom of Information Act 2000 (FOIA).

Our response

We can confirm that we hold information within scope of your request.

The <u>ICO25 Strategic Plan</u> was published in July 2022 and sets out the ICO's current programme to tackle privacy harms arising from the use of online tracking. This includes:

- exploring the use of targeted advertising of gambling on social media and the use of personal information within the gambling sector;
- influencing changes such as the phasing out of third-party cookies to create a more privacy-oriented internet; and



 working with government, industry and other regulators to give web users meaningful control over how they are tracked online and move away from cookie pop-ups.

In response to the second part of your request, we can confirm after having performed reasonable searches that the ICO has issued two enforcement actions that relate, at least in part, to Adtech, further details provided below. Please note, this figure excludes Information Notices and Assessment Notices, as we do not consider that these qualify as Enforcement Actions.

- 1) Reprimand issued to <u>Grindr</u> in July 2022- relates to poor practices around the platform sharing special category data with third parties who appear to be Adtech providers and/or data brokers.
- 2) Reprimand issued to the Government Communication Services in December 2021- relates to the use of real-time bidding technology.

This concludes our response.
