Request

You asked us:

- "1. Explain why consumers are not made aware of this?
- 2. Why have you not updated your redirection in place with the Royal Mail?
- 3. Why do you not give details of your correct postal address?
- 4. How long has this procedure been in place?
- 5. How many correspondences have been redirected by Royal Mail on behalf of ICO to your unknown address?
- 6. Can you please give us a breakdown of the cost ICO has incurred since the implementation of the redirection?
- 7. As taxpayers and members of the public, we are entitled to know why more direct address as noted above is not made known?
- 8. For the purpose of accountability and transparency, may we please request the ICO to disclose the address in South East of England where the correspondences are being directed to so we can send future correspondence directly to them."

We received your request on 21 July 2023.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

I have consulted with the relevant areas of the ICO and I can confirm that we hold some information in scope of this request. I have answered the questions below.

1. Explain why consumers are not made aware of this?

The privacy notice on ICO website was updated on the 25th of April 2022 to advise that our mail is redirected to Exela and opened by Exela.



2. Why have you not updated your redirection in place with the Royal Mail?

We still have the Royal Mail diversions and redirections in place.

3. Why do you not give details of your correct postal address?

The ICO postal address is the correct postal address. Mail sent to the ICO postal address will be received by the ICO.

4. How long has this procedure been in place?

The ICO's first digital mail solution was 13th of July 2020 when the ICO set up a variation to its storage contract to include a digital mail room. The current mail digital mail solution has been in place since 25th of April 2022.

5. How many correspondences have been redirected by Royal Mail on behalf of ICO to your unknown address?

All mail is redirected.

6. Can you please give us a breakdown of the cost ICO has incurred since the implementation of the redirection?

We are not able to provide a breakdown of the cost incurred by the ICO as it involves other costs such as hybrid working and a paperless office.

7. As taxpayers and members of the public, we are entitled to know why more direct address as noted above is not made known?

This is not a request for recorded information.

8. For the purpose of accountability and transparency, may we please request the ICO to disclose the address in South East of England where the correspondences are being directed to so we can send future correspondence directly to them

There is a clear process in place to send mail to the ICO. This is to send it to our postal address. Sending correspondence directly to Exela, rather than to the ICO, would risk mail not arriving at the ICO as it would not be addressed to us. It should also be noted that the quickest and most secure way to correspond with the ICO is via email.



Next steps

If we perform a review but you are still dissatisfied, you can complain to the ICO as regulator of the FOIA and EIR. This complaint will be handled just like a complaint made to the ICO about any other public authority.
