Request

You asked us:

Please note the phrasing - training materials linked purely to learning legislation/case law and NOT that which is linked with ICO corporate culture/procedures (things like style guides, customer service guides, instructions on how to use an internal system etc) - the disclosure is sought for legislation /case law training materials only."
