Request for information

Request received 9 October 2023:

"I would like to know how many complaints have you received about Imperial College Healthcare NHS Trust failure to comply with their obligations under the GDPR or Date Protection Act 2018.

Can you also confirm how many of those complaints you have upheld against the NHS Trust and what regulatory action your organisation has taken."

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). This legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

Our response

We do hold information in scope of your request. We currently hold information regarding 56 data protection complaints about Imperial College Healthcare NHS Trust in our casework management system. We do not record complaint outcomes as 'upheld' or 'not upheld'. Of the 56 complaints received, we have recorded the following outcomes:
