## **Request for information**

Request received 2 October 2023:

"Please refer to Disclosure IC-165258-G5K9 when answering this FOI request. For the past 2 years, I want to know how many times, and in regards to which authorities, was the "Non-compliance with DN or IN" [p3 of disclosure] form filled and e-mailed to <a href="mailto:xxx@ico.org.uk">xxx@ico.org.uk</a> [E-mail from p2 of disclosure].

Out of the previous Universe of PAs (and e-mails), please indicate how many cases proceeded all the way, up until the solicitor lodged the s54 certification in regards to the case. If there are any executive summaries (but not individual files) indicating why some cases were not pursued, please provide this as well."

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). This legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

### Our response to:

"For the past 2 years, I want to know how many times, and in regards to which authorities, was the "Non-compliance with DN or IN" [p3 of disclosure] form filled and e-mailed to xxx@ico.org.uk [E-mail from p2 of disclosure]."

We hold some information in scope of this request. Emails are retained in this specified inbox for twelve months before being deleted in line with our <a href="Retention and Disposal Policy">Retention and Disposal Policy</a>, so we only hold information for the past year.

There are currently 13 emails in the specified inbox with the completed form attached. These relate to the following public authorities:



Beckmead Trust, Bedford Borough Council, Bishop Grosseteste University, Civil Procedure Rules Committee, Commissioner of Police of the Metropolis, Department for Energy Security and Net Zero, Health and Safety Executive, London Borough of Haringey Council, Medicines and Healthcare Products Regulatory Agency, Royal Borough of Greenwich, Sandwell and West Birmingham Hospitals NHS Trust, Three Rivers District Council.

Please also note that the information requested is contained in the specified email inbox, but not in a way that enables a quick, automated search. We have extracted the information above through a manual search of the inbox.
