Request for information

Request received 23 October 2023.

The request is to know if a personal data breach report was made to the ICO by Invincibles Studio (formerly Soccer Manager), in or around July 2020.

Your request has been handled under the Freedom of Information Act 2000 (the FOIA). This legislation provides public access to recorded information held by a public authority unless an appropriate exemption applies.

Our response

We do not hold information in scope of your request. Having searched our casework management system I could not find a personal data breach (PDB) report matching the details you provided.

Further information

Please be aware that due to the ICO <u>Retention and Disposal Policy</u>, we do not hold casework records indefinitely. A report may have been made that has since been deleted.

Please also be aware that not every PDB is reportable to the ICO. In the event of a breach, an organisation must assess the risk to the individual(s) affected. We have guidance for when and how to Report a breach on our website.

We also regularly provide advice to data controllers by telephone to assist them with breach incidents. These calls are not recorded.

We publish details of <u>Personal data breach cases</u> reported to us in our <u>Complaints and concerns data sets</u>. Some more serious PDBs are referred to our investigations department, and these are shown in the relevant investigations datasets.



This concludes our response to your request.
