# Request

You asked us: "Could you kindly supply the following information relating to organisations for the following time periods –

- 1st April 2019 to 31st March 2020
- 1st April 2020 to 31st March 2021
- 1st April 2021 to 31st March 2022
- 1st April 2022 to date (6th October 2023)
- 1) The total number of penalties issued for non-payment of the data protection fee.
- 2) The total number of organisations that have paid a penalty on top the required data protection registration fee.
- 3) The total number of organisations that have paid the maximum penalty of £4,000 on top the required data protection registration fee.
- 4) The total number of organisations that have been subject to civil enforcement proceedings to recover non-payment of penalties.
- 5) The total number of penalties issued that have then been written off.
- 6) The reason/s for writing off the issued penalty/penalties."

We received your request on 6 October 2023.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Please note, although we write off penalty notices, we don't record the reason for writing off the issued penalty notice. As such, we do not hold this information.

Please also note, in relation to request 4, our reporting data appears to show the date of the penalty notice, rather than the date it was passed to our solicitors. For example, a penalty notice issued in March 2022 and sent to the solicitors in May 2023 appears to be shown in March 2022 figures. In accordance with our <u>guidance</u> on the FOIA, we have provided you the figures as they are <u>currently held</u> but have provided you with this information so that our response is as transparent as possible.
