Request

You asked us:

"Please could I request:

- a) The number of complaints made since 1 January 2018 about the following organisations:
- The Labour Party
- The Conservative Party
- The Liberal Democrats
- The Green Party of England and Wales
- b) Those complaints broken down into reason for complaint using whatever categorisation is used by the ICO, but at a minimum separating out those which relate to the organisations not complying with Subject Access Requests
- c) A summary breakdown of whether the ICO has upheld or not upheld those complaints
- d) Details of any action which has been taken against these organisations by the ICO since 1 January 2018, including any special monitoring of their compliance or assistance provided to them by the ICO to make them compliant with their legal responsibilities."

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We have searched our systems based on the information you provided and can confirm that we hold some information within the scope of your request.

It may be helpful to explain the ICO regularly disposes of old case files in line with our <u>Retention and Disposal Policy</u>. This means that we do not hold complaint records dating back to 1 January 2018. The oldest record we hold in scope of



your request dates to 7 June 2019. This means that for 1 January 2018 – 6 June 2019, no information is held within the scope of your request.

In searching our records, we have included complaints about both data protection and Freedom of Information. We have also included complaints about regional chapters of the 4 political parties you listed.

Please find attached a file containing all of the complaints we hold in scope of your request. This data set includes which party it is about, the legislative reason for the complaint, and the outcome of the complaint. Details from the data set will be presented in more detail below.

In your request you asked for complaints regarding Subject Access Requests (SARs). These will be presented in the column for 'Decision Primary Reason' as 'Art 15 - Right of access'.

The ICO does not classify complaints as 'upheld' or 'not upheld'. Instead, they are classified as 'No action,' 'No infringement,' 'Potential Infringement,' 'Infrigement,' and 'Investigation Pursued.'

Each of your specific question will be answered in detail in turn below.

a) The number of complaints made since 1 January 2018 about the following organisations:

- The Conservative Party
- The Liberal Democrats
- The Green Party of England and Wales

d) Details of any action which has been taken against these organisations by the ICO since 1 January 2018, including any special monitoring of their compliance or assistance provided to them by the ICO to make them compliant with their legal responsibilities

The ICO publishes all of our enforcement action <u>on our website</u>. This includes repirmands, monetary penalties, enforcement notices, and prosecutions.

<u>We also publish</u> enforcement notices, information notices, and practice recommendations specifically relating to FOI.

In 2020 we published an <u>audit report of data protection compliance by UK</u> <u>political parties</u>. This report is also available via the enforcement action page linked above.

Because this material is already reasonably accessible to you, it is technically withheld under section 21 of the FOIA. This exempts information which is reasonably accessible to the applicant through means other than a request under the FOIA.

It is an absolute exemption, which means it is not necessary for us to consider any public interest test.



No other information has been withheld from disclosure or redacted.

This concludes our response to your request.

Next steps

You can ask us to review our response. Please let us know in writing if you want us to carry out a review. Please do so within 40 working days.

If we perform a review but you are still dissatisfied, you can complain to the ICO as regulator of the FOIA. This complaint will be handled just like a complaint made to the ICO about any other public authority.
