We are now in a position to respond to your information request of 10 January.

Request

"This FOIA concerns artificial intelligence – as the ICO notes this is an umbrella term – it could include for example systems or tools primarily designed to process data (text, numbers, images or audio) using algorithm/machine learning technology, or systems that explicitly make use of AI models (LLM's, chatbots etc).

Under FOIA can you please provide:

The number of times since 01/01/2023 the ICO has been asked to a) carry out an audit b) provided written guidance, concerning proposed or planned new uses of artificial intelligence

- 1) Central government ministerial departments
- 2) UK police forces

Additionally please supply a) the name of the department or force b) the title and summary description of the purpose of the proposed system you were asked to audit/provide guidance o) a copy of any guidance sent, or summary of audit findings."

We have handled your request under the Freedom of Information Act 2000 (FOIA).

Our response

We have interpreted your request to be about requests we have received from these organisations to carry out an audit (a), provide written guidance (b), concerning proposed or planned new uses of artificial intelligence (AI) since 1 January 2023.



Having consulted with relevant teams within the ICO, we can confirm we do not hold information within scope of your request. We have not been asked by these organisations to carry out an audit or provide written guidance on proposed or planned new uses of AI in this timeframe.
