Request

In summary, you asked us:

- "1. Please could you provide me with the number of 'Letter A's issued/sent out in 2023
- 2. Please could you provide me with the number of 'Letter B's issued/sent out in 2023
- 3. Please could you provide me with the number of 'Letter C's issued/sent out in 2023
- 4. Please could you provide me with the number of 'Letter D's issued/sent out in 2023
- 5. Please could you provide me with the number of 'Letter E's issued/sent out in 2023
- 6. Please could you provide me with the number of 'pre-action section 54 letters issued/sent out in 2023
- 7. In cases where a PA can't comply for some valid reason, please provide number of Affidavit/Formal Certificates signed in 2023
- 8. In respect of Annex 1 to Practice Direction 81, how many times did a Solicitor on behalf of the ICO lodge the documents with the administrative court and pay the relevant fee?"

Your request referred to the documents disclosed as a part of the request handled under IC-165258-G5K9.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).



Our response

We have searched our records based on the information you provided and can confirm that we hold some information within the scope of your request.

For clarity, we have interpreted 'Letter A' to mean the template on page 5 of the attachment, 'Letter B' to mean the template on page 6, 'Letter C' the template on page 7, 'Letter D' the template on page 8, and 'Letter E' the template on page 9.

Please be advised that the templates disclosed under IC-165258-G5K9 are meant to advise Case Officers but may not be used by Case Officers. Some COs choose to draft new letters for every case they handle. Addionally, COs often call Public Authorities at this stage in a complaint process and so the template letters are not needed. This is to say that using or not using a template letter does not necessarily reflect the amount of work done on a case.

In response to questions 1-5 of your request, in 2023, there were 3 Letter A's sent, 6 Letter B's, 1 Letter C, 1 Letter D, and no Letter E's sent.

In response to question 6, 2 'pre-action' letters were sent in 2023.

No information is held within the scope of questions 7 and 8 of your request. That is, no affidavit/formal certidicates were signed and there were no instances of a solicitor on behalf of the ICO lodging the documents with the administrative court and paying the relevant fee.

No information has been redacted or withheld from disclosure.

This concludes our response to your request.

Next steps
