Request

I am writing to you under the Freedom of Information Act 2000 to request information regarding the full departmental structure of the Information Commissioner's Office (ICO) in-house legal department, including the number of Full-Time Equivalent (FTE) posts at each grade.

Specifically, I am seeking details such as:

- 1. The hierarchical structure of the legal department, including all job titles and corresponding grades.
- 2. The number of FTE posts at each grade within the legal department.
- 3. Any organisational charts, if available, depicting the structure of the legal department.
- 4. Any additional information pertinent to the composition and organisation of the legal department.

If possible, I would prefer to receive the requested information electronically, in a format that is easily accessible and readable, such as PDF or Excel.
