We have handled your request for recorded information under the Freedom of Information Act 2000 (FOIA).

## **Our response**

We understand your request relates to the guidance we have on our website regarding the interaction of sections 23 and 24 of the FOIA, available <a href="here">here</a>.

We can confirm we hold some information within scope of your request. The first version we hold of this guidance is dated 26 September 2012 and is marked as version 1.0.

We do not hold the date of when this guidance was published on our website but it will have been shortly after 26 September 2012.
