Request

You asked us:

"I'm interested in what legal basis the ICO use for the following processing:

- Providing e-learning to staff which are not direct legal requirements of the ICO's legislation (e.g. Health & safety learning, gifts & hospitality)
- Maintaining a record of that learning at an individual level
- Creating reports of learning completion to ensure completion."

"Please provide the information the ICO holds about its lawful basis for processing staff personal data for self directed e-learning courses and reporting on training completion. I'm particularly interested in courses that cover general public sector learning needs, for example money laundering, safeguarding, gifts and hospitality etc."

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We can confirm that we hold some information in scope of your request.

The ICO pro-actively publishes our staff privacy policy on our website. You can find version 3.1 of this policy at the following link: https://ico.org.uk/media/4027966/staff-privacy-notice-2024.pdf

Section 4 identifies the lawful bases the ICO relies on for processing staff personal data. Section 3 identifies the staff personal data that the ICO processes, with 3.3 specifically listing information related to performance and training.



Section 10.8 further identifies processing using online learning platforms and Annex A links to the relevant data processors' privacy notices. On review, some of the relevant hyperlinks in Annex A no longer work correctly. We are in the process of updating our staff privacy policy to version 3.3, which is intended for publication on the website and will correct this issue with hyperlinks.
