We are now in a position to respond to your information request of 25 April.

Request

"Subject: FOI request - disclosure notices

Please release the following information under the terms of the Freedom of Information Act.

- [1]. Which five authorities have received the most enforcement notices from the ICO since the Act became operational?
- [2]. For each authority, how many enforcement notices have they received, when was each enforcement notice issued, and provide a brief summary of the reason for the notice.
- [3]. How many times has the ICO commenced Court proceedings under section 54 of the Act, which may be dealt with as contempt of Court? Which authorities were subject to the proceedings in each case. What was the outcome of proceedings in each case."

We have handled your request for recorded information under the Freedom of Information Act 2000 (FOIA).

Our response

We understand your request relates to enforcement notices issued by the ICO as regulator under section 52 of the FOIA. Please find below information in response to your questions.

We publish details of our FOIA enforcement notices (ENs) on our website here. These are currently available from September 2022. Previous enforcement notices can be found on The National Archives (TNA) website.



Prior to September 2022 we issued 3 ENs, with a further 1 EN issued before the full provisions of the FOIA came into force on 1 January 2005. We have provided the TNA links to the 2006, 2010 and 2015 ENs for ease of reference. The 2003 EN is enclosed as a separate attachment.

In answer to your questions in parts 1 and 2, no public authority has received more than one EN. With regards to point 3, we have never issued court proceedings under section 54 of the FOIA.

You may find our <u>FOI year in review</u> blog helpful in your area of interest. In this, our Director of Freedom of Information and Transparency discusses the development of a process for using this power in 'The year ahead' section.

The published information within scope of your request is technically withheld under section 21 of the FOIA, which explains we are not required to provide information in response to a request if it is already reasonably accessible to you from another source.
