Request

On 5 July 2024 you requested the following information:

- What were the total number of visits to your website? (i.e. all visits to any part of your website) during the Relevant 12 Month Period?
- What were the total number of uniquer users visiting your website (i.e. all visits to any part of your website) during the Relevant 12 Month Period?
- What were the total number of visits to your Privacy Notice Webpages during the Relevant 12 Month Period?
- What were the total number of unique users visiting your Privacy Notice Webpages during the Relevant 12 Month Period?
- What was the average amount of time spent by visitors during a visit to your Privacy Notice Webpages during the Relevant 12 Month Period? i.e. When someone visited those pages, how many seconds did they spend before navigating to a new page?

For these purposes, "Relevant 12 Month Period" would ideally be July 2023 - June 2024 but happy for you to use a similar 12 month period if that is more convenient. The term "Privacy Notice Webpages" means https://ico.org.uk/global/privacy-notice/.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Response

We hold information that falls within scope of your request. During the time period specified we recorded:

• 25.2 million page views (across our entire website)



- 6.2 million visitors to our website please note that our analytics tools cannot tell us which are return users, and which are unique due to it not using cookies to collect user information
- 77,300 views of our privacy notice pages
- 39,300 visitors to our privacy notice pages please note that our analytics tools cannot tell us which are return users, and which are unique due to it not using cookies to collect user information
- An average of 28.28 seconds spent on our privacy notice pages

This concludes our response to your request.

Next steps

You can ask us to review our response. Please let us know in writing if you want us to carry out a review. Please do so within 40 working days.

If we perform a review but you are still dissatisfied, you can complain to the ICO as regulator of the FOIA. This complaint will be handled just like a complaint made to the ICO about any other public authority.
