## Request

You asked us: "I am writing to a request under the Freedom of Information Act related to the ICO's handling of complaints related to journalism. The ICO's review of the processing of personal data for the purposes of journalism under the Data Protection Act 2018 (<u>https://ico.org.uk/media/about-the-</u> *ico/documents/4029002/journalism-outcomes-report.pdf*) stated at page 8 that between February 2020 and March 2022 the ICO received 488 such complaints. However, other than recording that no enforcement action was taken by the ICO in respect of journalism in the period under review, it provided no information on how these complaints were handled. Please can you therefore provide information on how many of these 488 complaints resulted in an ICO finding of "infringement", "likely infringement" and "potential infringement" and what other outcomes at a similar level of abstraction were recorded (also with relevant numbers so categorised)."

We received your request on 19 November 2024.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

#### Our response

Having conducted a reasonable search of our records, we can confirm that we do not hold information in the scope of your request. This is because we no longer hold cases as far back as the timescales requested as they have been deleted in accordance with our retention period.

We can also advise that we have checked our oldest <u>data sets</u> and can confirm that there are no cases in the scope of your request held here either.

<u>Archived versions</u> of our website are held via The National Archives' UK Government Web Archive. As such, it may be possible to locate some or all the




information you have request by reviewing old versions of our datasets via this third party site.
