

Senior Leadership Team – minutes

1. Introductions and apologies

Apologies for absence were received from Emma Bate.

Paul Arnold welcomed Angela Donaldson to her first SLT meeting.

2. Declarations of interests

4. Half Year Financial Performance Review

Discussion

Louise Byers presented the paper and summarised that we are on track on our income target and thanked Mike Fitzgerald and the registration teams for all their hard work in this area. The Board also considered a number of changes to expenditure budgets and areas where year to date spending has been lower than expected, for example in relation to travel.

In addition, a number of business cases were considered for prioritisation. These cases were reviewed and were recommended to SLT for approval.

Louise and Jo Butler highlighted that it is important for areas of the business to submit business cases throughout the year, as business needs and requirements are identified, not just at the beginning of the business plan process.

Louise Byers confirmed that as at this point she was not aware of any additional business cases that require funding.

Decision

At its November meeting, the Senior Leadership Team approved the funding of the business cases as outlined in the report.

5. Good Faith Document

Discussion

Sarah Lal presented the draft good faith document highlighting that the document is proposed to frame our approach to engagement and consultation with our trade unions as part of our wider industrial relations.

She confirmed that she had conducted clear, transparent and constructive discussions with the unions about what we are trying to achieve and acknowledged the important part trade unions play in our relations with members of staff. SLT discussed the role that they would all play in ensuring high quality industrial relations.

Decision

The Senior Leadership Team agreed that this is a positive step and supported the good faith document.
