

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 27 June 2023

Public Authority: Local Government Association

Decision (including any steps ordered)

1. The complainant requested information from the Local Government Association ("the LGA") about the Information and Development Agency for Local Government. By the date of this notice, the LGA had not issued a substantive response to this request.

- 2. The Commissioner's decision is that the LGA has failed to complete its deliberations on the balance of the public interest within a reasonable time and has therefore breached section 17(3) of FOIA.
- 3. The Commissioner requires the LGA to take the following step to ensure compliance with the legislation.
 - Having confirmed whether or not information is held within the scope of the request: either disclose the requested information, if held, or, to the extent that information is to be withheld, issue a refusal notice in accordance with the requirements of section 17 of the FOIA.
- 4. The LGA must take this step within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of FOIA and may be dealt with as a contempt of court.

Request and response

5. On 21 February 2023, the complainant made the following request for information to the LGA:



"This is a request under the Freedom of Information Act for some information related to the Information and Development Agency for Local Government ("IDeA").

My understanding is that both the LGA and IDeA are public bodies for the purposes of the FOI Act. To the extent that the LGA and IDeA are separate legal entities, please treat this email as a request for information sent to both entities.

IDeA Company Board papers were previously accessible to the public on the LGA's website. However, I understand this practice was discontinued in

Please provide the following information: agendas and minutes of any meeting of the IDeA Company Board held or scheduled to be held from July 2020 to date.

My request for minutes includes any papers, action logs, presentations, or attachments circulated to attendees with the minutes or for the purposes of their participation in the meetings.

Thank you for your assistance with this request for information."

6. On 21 March 2023, the LGA wrote to the complainant to explain that it held information relevant to the complainant's request, but that it would need to extend the time taken to complete its public interest test considerations under sections 36, 40, 41 and 43 of FOIA.

Reasons for decision

7. Section 1(1) of FOIA states that:

"Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him."
- 8. Section 10(1) of FOIA states that a public authority must respond to a request promptly and "not later than the twentieth working day following the date of receipt".



- 9. Section 17(3) of FOIA states that where a public authority is relying on a qualified exemption, it can have a "reasonable" extension of time to consider the public interest in maintaining the exemption or disclosing the information.
- 10. FOIA does not define how long a reasonable time is. The section 45 Code of Practice on request handling states that "it is best practice for an extension to be for no more than a further 20 working days". This means that the total time spent responding to a request should not exceed 40 working days unless there are exceptional circumstances.
- 11. On 31 May 2023 the Commissioner wrote to the LGA, reminding it of its responsibilities and asking it to provide a substantive response to the complainant within 10 working days. To date, a substantive response has still not been provided.
- 12. In this case, the total time taken by the LGA has exceeded 40 working days. The Commissioner does not consider there to be any exceptional circumstances and finds that, by failing to complete its deliberations on the public interest within a reasonable time frame, the LGA has not complied with section 17(3).
- 13. The LGA is now required to finalise its public interest considerations under section 17(3) of FOIA and respond to the complainant.
