Request

In summary, you asked us:

- "1. For registration reference ZB512880, data controller name "Stags":
- a) When registering, what type of organisation/company (eg Limited, LLP) did the fee payer indicate they were and what company number (if any) was provided?
- b) Is an individually named data protection officer / senior responsible person held for this organisation and if so, what type of data is held about them (eg. full name, address, email address, phone number)?
- c) How many complaints have there been for this organisation?
- d) Please provide any (disclosable) details of any cases, decisions or other outcomes resulting from any complaints or investigations for this organisation.
- 2. Has the company "Stags 1874 Limited" with company number 07185852 ever been registered with the ICO?
- 3. Were there any other organisations with the name "Stags" or "Stags Estate Agents" registered with the ICO prior to 15 February 2023, and if so, the names and registration reference numbers for these?"

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We have searched our records based on the information you provided and can confirm that we hold information within the scope of your request.

For clarity, we will answer each part of your request in turn.

- 1. For registration reference ZB512880, data controller name "Stags":
- a) When registering, what type of organisation/company (eg Limited,



LLP) did the fee payer indicate they were and what company number (if any) was provided?

Stags, controller reference ZB512880, registered as a 'Partnership.' The listed sector is 'Land or property services', sub-sector 'Estage agency/Letting agency.' No company number was provided at time of registration.

b) Is an individually named data protection officer / senior responsible person held for this organisation and if so, what type of data is held about them (eg. full name, address, email address, phone number)?

There is no registered DPO but the registration does include a 'Main contact.' Their name, job title, email address, phone number, and postal address is held in relationship to the organisation's registration.

c) How many complaints have there been for this organisation?

The ICO currently holds no data protection complaints regarding this organisation.

It may be helpful to explain that records held by the ICO are regularly disposed of in line with our <u>Retention and Disposal Policy</u>. Complaint case files are held for two years following case closure. This means that it is possible that the ICO has received previous complaints about the organisation more than two years ago, but that the information has been erased in line with this policy.

d) Please provide any (disclosable) details of any cases, decisions or other outcomes resulting from any complaints or investigations for this organisation.

No complaints are held regarding this organisation, as above.

2. Has the company "Stags 1874 Limited" with company number 07185852 ever been registered with the ICO?

We have no record of this organisation having been registered with the ICO.

However, lapsed registration information is erased after 2 years in line with the Retention and Disposal Policy linked above. This means that if 'Stags 1874 Limited' was registered with the ICO but ceased paying their data protection fee more than 2 years ago, we would no longer hold records of their registration.



3. Were there any other organisations with the name "Stags" or "Stags Estate Agents" registered with the ICO prior to 15 February 2023, and if so, the names and registration reference numbers for these?

We currently hold one other registration record that may be in scope of your request. This is for Stag Estates Norfolk Ltd, registrastion <u>ZB523936</u>.

No other information is held within the scope of your request. No information has been redacted or withheld from disclosure.

This concludes our response to your request. We hope this information is useful to you.

Next steps
