# Request

You asked us:

Please could you confirm the registration status of each company on the list?

We received your request on 21 February 2025.

We have handled your request under the Freedom of Information Act 2000 (the FOIA).

## **Our response**

We confirm having searched our records in respect of the companies listed above and can confirm that we do hold information falling within the scope of your request within our Data Protection Fees database containing details of those organisations registered with the ICO.



Our searches have disclosed that, of the nine organisations listed above, all but two currently have live and active registrations in force with the ICO as at the date of this request being submitted (**21 February 2025**).

The following two organisations have been registered with the ICO in the past but show a registration status of "Lapsed" on our system.

## Information withheld - FOIA section 21

In the latter case, the organisation will be excluded from the Register until such time as the renewal fee is paid.
