HEI's will process data relating to Art 9 data including welfare, medical evidence etc etc. HEIs are complex organisations where personal data may be included in emails. The student or staff request for all my personal data will involve an extensive search of not just the central student/ staff HR file but departmental records, staff emails, records held in student welfare departments, counselling departments, accommodation and estate departments, minutes of awards boards, examiners meetings, complaints or disciplinary areas, placement records and so forth and so forth.
