We have interpreted your request for Data Protection Impact Assessments (DPIAs) conducted by the ICO in 2023, to be ICO DPIAs that were signed off (completed) in 2023. We completed 20 DPIAs in 2023.

2. Can you please advise if these were a full assessment or a screening?

These were full DPIAs.

In line with our request handling procedures, the enclosed attachments are in PDF format. The Word version of the DPIA template has dropdown items within the document. We have provided a list of these item choices in a separate annex as they are not viewable in the PDF version. Some of these options have values which produce a risk level score. The scoring criteria is given on pages 30 to 32 of the DPIA template.

Please note, the bookmark error message on page 2 of the process for completing ICO DPIAs document appears in both Word and PDF.
