We have handled your request under the Freedom of Information Act 2000 (the FOIA).

Our response

We have searched our records based on the information you provided and can confirm that we hold some information within the scope of your request.

It may be helpful to explain that records held by the ICO are regularly disposed of in line with our <u>Retention and Disposal Policy</u>. Complaint files are normally held for 2 years. This means that complaints received more than 2 years ago have been erased in line with this policy. However, we have provided all of the information in scope of your request that we do hold.
