

Hope this finds you both well. Just a quick update for MS progress.

MS have agreed, thus far, to make all the changes we have asked for in their DPAdd for Microsoft Azure. However, they have said they will do this for SPA/PSoS and Axon. I muted the point that it should be in the DPAdd for all customers, but they responded that no-one else had asked them. Obviously I need to try and persuade them to change it for all users as we want to be able to do business with 3<sup>rd</sup> parties using Azure without having to ask them to approach ICO and ask for their terms to be changed.

So...good news for the DESC project. Our lawyers are just going to circle back this week and make sure this resolves all out concerns or whether we should buy the advanced data residency offering as well.



So bit of a mixed bag, but I kind of feel vindicated for raising the issues – getting MS to agree to change some things for us is, in my view, a huge win and opens the door for closer working in the future.
