

Freedom of Information Act 2000 (FOIA) Decision notice

Date: 12 August 2020

Public Authority: Great Dunham Parish Council Address: greatdunhampc@gmail.com

Decision (including any steps ordered)

- 1. The complainant requested information relating to payments made by Great Dunham Parish Council to the SLCC. A substantive response to the request had not been provided by the date of this notice.
- 2. The Commissioner's decision is that Great Dunham Parish Council ("the Parish Council") failed to respond to the request within 20 working days and has therefore breached section 10 of the FOIA.
- 3. The Commissioner requires Great Dunham Parish Council to take the following steps to ensure compliance with the legislation.
 - Issue a substantive response, under the FOIA, to the request.
- 4. Great Dunham Parish Council must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the FOIA and may be dealt with as a contempt of court.



Request and response

5. On 30 March 2020, the complainant wrote to Great Dunham Parish Council and requested information in the following terms:

"I note that in your February minutes you have missed out the amount paid to the SLCC. As you are aware all amounts authorised by a Council, with the exception of wages must be recorded in the minutes for accounting and audit purposes. You will see from the copy of the Weasenham agenda the amount should be £21 making it up to the half of the £122 bill. Under the Freedom of Information Act can you tell me how much was authorised at this meeting and who decided that Great Dunham's share should only be one third initially."

6. Great Dunham Parish Council acknowledged the request on 19 April 2020 but had failed to provide a substantive response by the date of this notice.

Scope of the case

- 7. The complainant contacted the Commissioner on 6 May 2020 to complain about the failure by the Parish Council to respond to the request.
- 8. In line with her usual practice, the Commissioner contacted Great Dunham Parish Council on 24 June 2020 to highlight the outstanding response. She requested that the Parish Council respond to the request within 10 working days. The correspondence was neither acknowledged nor responded to.
- 9. The complainant contacted the Commissioner on 17 July 2020 to request a decision notice considering the Parish Council's compliance with the FOIA.
- 10. The scope of this notice and the following analysis is to consider whether Great Dunham Parish Council has complied with section 10 of the FOIA.



Reasons for decision

11. Section 1(1) of the FOIA states that:

Any person making a request for information to a public authority is entitled –

- (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
- (b) if that is the case, to have that information communicated to him.
- 12. Section 8(1) of the FOIA states:

In this Act any reference to a "request for information" is a reference to such a request which –

- (a) is in writing,
- (b) states the name of the applicant and an address for correspondence, and
- (c) describes the information requested.
- 13. The Commissioner considers that the request in question fulfilled these criteria and therefore constituted a valid request for recorded information under the FOIA.
- 14. Section 10 of the FOIA states that responses to requests made under the Act must be provided "promptly and in any event not later than the twentieth working day following the date of receipt."
- 15. From the evidence presented to the Commissioner in this case, it is clear that, in failing to issue a substantive response to the request within 20 working days, Great Dunham Parish Council has breached section 10 of the FOIA.



Right of appeal

16. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
