

Environmental Information Regulations 2004 (EIR)

Decision (including any steps ordered)

1. The complainant has requested information in relation to specific road closures and low traffic neighbourhoods (LTNs).
2. The Commissioner's decision is that London Borough of Croydon ("the Council") has failed to respond to the request within 20 working days and has therefore breached Regulation 5(2) of the Environmental Information Regulations ("the EIR").
3. The Commissioner requires the Council to take the following steps to ensure compliance with the legislation.
 - Issue a substantive response, under the EIR, to the request.
4. The Council must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Freedom of Information Act and may be dealt with as a contempt of court.

Request and response

5. On 15 April 2021, the complainant wrote to the Council and requested information in the following terms:

"Which Croydon officer/s had discussions with Bromley counterparts about the closures of Stambourne Way, Sylvan Hill and Fox Hill on or prior to July 25th 2020?

Which Croydon officer/s was / were involved in these discussions?

Given that the Crystal Palace LTN was introduced separately to the South Norwood LTN please could you state:

Whose decision it was to merge the LTNs into one?

When this decision was taken?

Reasons for the decision."

6. The Council acknowledged the request on 23 April 2021 but had failed to provide a substantive response by the date of this notice.

Scope of the case

7. The complainant contacted the Commissioner on 13 August 2021 to complain about the way his request for information had been handled.
8. In line with her usual practice, the Commissioner contacted the Council on 9 September 2021 to highlight the outstanding response. She requested that the Council respond to the request within 10 working days. The correspondence was neither acknowledged nor responded to.
9. The Commissioner considers that the scope of her investigation is to determine whether the Council has complied with Regulation 5(2) of the EIR.

Reasons for decision

10. Regulation 2(1) of the EIR defines environmental information as being information on:

- (a) *the state of the elements of the environment, such as air and atmosphere, water, soil, land, landscape, and natural sites including wetlands, coastal and marine areas, biological diversity, and its components, including genetically modified organisms, and the interaction among these elements*
- (b) *factors, such as substances, energy, noise, radiation, or waste, including radioactive waste, emissions, discharges, and other releases into the environment, affecting or likely to affect the elements of the environment referred to in (a);*
- (c) *measures (including administrative measures), such as policies, legislation, plans, programmes, environmental agreements, and activities affecting or likely to affect the elements and factors referred to in (a)...as well as measures or activities designed to protect those elements;*
- (d) *reports on the implementation of environmental legislation;*
- (e) *cost-benefit and other economic analyses and assumptions used within the framework of the measures and activities referred to in (c); and*
- (f) *the state of human health and safety, including the contamination of the food chain, where relevant, conditions of human life, cultural sites and built structures inasmuch as they are or may be affected by the state of the elements of the environment referred to in (a) or, through those elements, by any of the matters referred to in (b) and (c);*

11. The Commissioner has not seen the requested information but, as it is information relating to road closures and LTNs, she believes that it is likely to be information about activities affecting or likely to affect the elements of the environment. For procedural reasons, she has therefore assessed this case under the EIR.

12. Regulation 5(1) states that: "*a public authority that holds environmental information shall make it available on request.*"

13. Regulation 5(2) states that such information shall be made available "*as soon as possible and no later than 20 working days after the date of receipt of the request.*"

14. The Commissioner considers that the request in question constituted a valid request for information under the EIR.

15. From the evidence presented to the Commissioner in this case, it is clear that, in failing to issue a response to the request within 20 working days, the Council has breached Regulation 5(2) of the EIR.

Right of appeal

16. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
