

Environmental Information Regulations 2004 (EIR)

Decision notice

Decision (including any steps ordered)

1. The complainant has requested information from Gwynedd Council ("the Council") for planning, development and flood risk documents relating to a property.
2. The Commissioner's decision is that the Council has failed to carry out a reconsideration (internal review) of a response it provided under the EIR within 40 working days. It has therefore breached regulation 11 of the EIR.
3. The Commissioner requires the Council to take the following steps to ensure compliance with the legislation.
 - Reconsider how it responded to the original request and inform the complainant of the outcome of that reconsideration in accordance with regulation 11 of the EIR.
4. The Council must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Freedom of Information Act and may be dealt with as a contempt of court.

Request and response

5. On 8 October 2021, the complainant wrote to the Council and requested information in the following terms:

"A copy of all information held by Gwynedd Council that dates between January 1st 2018 and the present time in relation to an application made on 6th March 2018 for "prior notification of agricultural or forestry development - proposed road. Town and Country Planning General Permitted Development Order 1995 Schedule 2, parts 6 & 7", for a property identified as [redacted].

The application Number is believed to have been C18/0181/44/YA

The request also asks for copies of any assessments held by Gwynedd Council in relation to flood risks in the Natural Resources Wales defined flood plain in Borth-y-Gest of which this site is part."

6. The Council responded to the request on 23 November 2021.
7. The complainant requested an internal review on 1 January 2022, but the Council had not completed its review at the date of this notice.

Scope of the case

8. The complainant contacted the Commissioner on 30 March 2022 to complain about the way this request for information had been handled.
9. The Commissioner contacted the Council on 4 April 2022 to highlight the outstanding internal review and asked the Council to complete its reconsiderations within 10 working days.
10. Despite this intervention the Council has failed to respond to the complainant.
11. The scope of the Commissioner's investigation is to determine whether the Council has complied with regulation 11 of the EIR.
12. For the avoidance of doubt, the Commissioner has not yet considered and therefore takes no position on whether the Council was entitled to rely on the exception(s) which it has done.

Reasons for decision

13. Regulation 11¹ of the EIR states that:

“(3) The public authority shall on receipt of the representations and free of charge—

(a) consider them and any supporting evidence produced by the applicant; and

(b) decide if it has complied with the requirement.

(4) A public authority shall notify the applicant of its decision under paragraph (3) as soon as possible and no later than 40 working days after the date of receipt of the representations.”

14. From the evidence presented to the Commissioner in this case it is clear that, in failing to carry out an internal review within 40 working days, the Council has breached regulation 11 of the EIR.
