Decision

1. The complainant requested a copy of the recording of a Town Council meeting from Middlewich Town Council ("the Council"). The Commissioner's decision is that the Council has disclosed all the information it holds within the scope of the request.

Request and response

2. The complainant made the following information request to the Council on 24 December 2021:

"Could you please provide the audio copy of the five hundred and forty first Middlewich Town Council meeting held on 20th of December 2021."

3. The final position of the Council is that it has provided all the information it holds within the scope of the request.

Reasons for decision

- 4. This reasoning covers whether the Council stated correctly that it holds no further information falling within the scope of the complainant's request to that which it disclosed.
- 5. In response to the request, the Council provided the complainant with a partial recording of the Council meeting. The complainant considers the Council to hold a full recording of the Council meeting.
- 6. The Council's position is that it has disclosed all the information it holds within the scope of the request. The Council explained that whilst it did hold a copy of the full recording of the meeting, the information is no longer held as the previous Parish Clerk edited the recording of the Council meeting and did not keep the original version.
- 7. The Commissioner accepts the Council's reasoning for not holding a copy of the full recording of the Council meeting. On this basis, his decision is that on the balance of probabilities the Council has disclosed to the complainant all the information it holds within the scope of the request. The Commissioner requires no further action to be taken by the Council in relation to this request.
