Section 51

Under section 51 of the Freedom of Information Act 2000 (FOIA), which is set out below, the Information Commissioner (the Commissioner) has the power to serve a notice on a public authority requiring it to furnish him with any information he requires to enforce the requirements of FOIA.

- 51. (1) If the Commissioner -
 - (a) has received an application under section 50, ...

he may serve the authority with a notice (in FOIA referred to as "an information notice") requiring it, within such time as is specified in the notice, to furnish the Commissioner, in such form as may be so specified, with such information relating to the application, to compliance with Part I or to conformity with the code of practice as is so specified.

 The Commissioner has received an application under section 50, reference IC-338623-S4K4, for a decision whether a request for information made by the complainant to Morecambe Town Council on 18 April 2024, has been dealt with in accordance with the requirements of Part I of FOIA. Nature of complaint

2. The Commissioner wrote to Morecambe Town Council on 4 March 2025 to set out the information he required in order to determine the complaint. He asked Morecambe Town Council to respond by 11 March 2025.

3. At the date of this notice, that correspondence has been neither acknowledged nor responded to.

Information required

- 4. In view of the matters described above the Commissioner hereby gives notice that in the exercise of his powers under section 51 of FOIA he requires that Morecambe Town Council shall, within 30 calendar days of the date of this notice, furnish the Commissioner with a copy of the following information:
 - A substantive response to the Commissioner's letter dated 4 March 2025.

Failure to comply

5. Failure to comply with the steps described above may result in the Commissioner making written certification of this fact to the High Court (or the Court of Session in Scotland) pursuant to section 54 of FOIA, and may be dealt with as a contempt of court.
