Executive summary



Audit Methodology

The Information Commissioner is responsible for enforcing and promoting compliance with the UK General Data Protection Regulation (UK GDPR), the Data Protection Act 2018 (DPA 2018) and other data protection legislation. Section 146 of the DPA 2018 provides the Information Commissioner's Office (ICO) with the power to conduct compulsory audits through the issue of assessment notices. Section 129 of the DPA 2018 allows the ICO to carry out consensual audits.

The ICO is an independent, proportionate regulator and sees auditing as a constructive process with real benefits for controllers and so aims to establish a participative approach. High standards of personal data protection compliance help organisations innovate and deliver great services by building trust with the public. The ICO's expertise and consistent approach to regulation provides certainty enabling organisations to feel confident to use personal data responsibly, innovate and support economic growth.

Hampshire & Isle of Wight Constabulary and Thames Valley Police (HIOWCTVP) are two Police Forces who share their information management function. HIOWCTVP agreed to a consensual audit of its data protection practices.

The purpose of the audit is to provide the Information Commissioner and HIOWCTVP with an independent assurance of the extent to which HIOWCTVP, within the scope of this agreed audit, is complying with data protection legislation.

The scope areas covered by this audit are determined following a risk based analysis of HIOWCTVP's processing of personal data. The scope may take into account any data protection issues or risks which are specific to HIOWCTVP, identified from ICO intelligence or HIOWCTVP's own concerns, or any data protection issues or risks which affect its specific sector or organisations more widely. The ICO has further tailored the controls covered in each scope area to take into account the organisational structure of HIOWCTVP, the nature and extent of HIOWCTVP's processing of personal data, and to avoid duplication across scope areas. As such, the scope of this audit is unique to HIOWCTVP.

It was agreed that the audit would focus on the following area:

Management and	respond to security breaches involving personal data, to record them appropriately
Reporting	and notify the supervisory authority and individuals where appropriate

Audits are conducted following the Information Commissioner's data protection audit methodology. The key elements of this are a desk-based review of selected policies and procedures, remote interviews with selected staff, and a virtual review of evidential documentation.

Where weaknesses were identified recommendations have been made, primarily around enhancing existing processes to facilitate compliance with data protection legislation. In order to assist HIOWCTVP in implementing the recommendations each has been assigned a priority rating based upon the risks that they are intended to address. The ratings are assigned based upon the ICO's assessment of the risks involved. HIOWCTVP's priorities and risk appetite may vary and, therefore, they should undertake their own assessments of the risks identified.




Audit Summary

The audit has identified some scope for improvement in existing arrangements to reduce the risk of non-compliance with data protection legislation.


The assurance rating above is reflective of the remote audit methodology deployed and the rating may not necessarily represent a comprehensive assessment of compliance.

Priority Recommendations



The bar chart above shows a breakdown of the priorities assigned to our recommendations made. Personal data breach management and reporting has four high, two medium and two low priority recommendations.

The pie chart above shows a summary of the assurance rating awarded in the personal data breach management and reporting scope. 43% high assurance, 28% reasonable assurance and 29% limited assurance.



Key areas for improvement

We identified some key areas within our audit, where HIOWCTVP needed to implement further measures to comply with data protection law.

- HIOWCTVP must ensure that all staff groups who are processing personal data on its behalf receive training to be able to recognise and escalate personal data breaches.
- HIOWCTVP must ensure that training completion statuses are accurately recorded.
- HIOWCTVP must ensure that all staff accessing personal data remain aware of data purpose use, proportionality and necessity.
- HIOWCTVP must ensure that the scope of the controls adopted to ensure that use and access to personal data complies with agreed standards includes all systems in use.
